1. PFF strategic focus for 2015

Our board of trustees decided last year to expand our work to the Eastern Cape and Gauteng. This coincided with the relocation of two trustees to the respective provinces. Instead of seeing this as a loss we decided to view it as an opportunity. With our limited resources we implemented this strategic choice. This meant that our work in the Western Cape had to be downscaled.

2. Our vision and mission

Vision: An effective, strong, sustainable and vibrant community-based sector in South Africa.

Mission: To work in collaboration with community-based organisations in South Africa to strengthen their capacity to effectively mobilise resources, deliver valuable services to their communities and contribute meaningfully towards the eradication of poverty.

Our vision and mission statements are fairly clear. The question is: to what extent have we been able to successfully execute it in the current challenging circumstances?

Quarterly newsletter

2 newsletters were issued during this period focusing on a variety of topics such as the funding crisis, leadership issues, networking, trustee appointments, relevant NPO resources, etc. Our newsletter was sent to about 1000 NPOs captured on our database. The database is currently increasing as more and more people are subscribing. We need to urgently update our database with new NPOs who have attended our events. The rate of opening our newsletter is not good and feedback is very sporadic.

A need exists to develop a brochure for the PFF that can be distributed at events. This brochure must capture the history of PFF, our organizational design and programmatic focus. Feedback from NPO leaders should be included.

Media, marketing and communications

Our primary marketing tools during this period have been:

- Our electronic newsletter
- Block emails promoting our capacity building workshops and forwarding information from partners about events.
- Trustees have done their bit in promoting PFF in the various forums where they are active.
- Displaying our banners at strategic events

Governance:

Funding and finances

Just like previous years, our major income was derived from workshop fees. A number of bursaries were allocated to non-funded NPOs in line with our mission to create access to survivalists NPOs. In the Eastern Cape we were fortunate that the Ikhala Trust sponsored the bursaries of about 12 NPO leaders to attend our workshop in Port Elizabeth. This helped to cover our costs. We were also provided with a donation from SAFULA of R5000 as part of a partnership with Andrew Mack from the USA.

Our Leadership Forum in Cape Town was sponsored with R5000 by the Community Chest. Income generated from workshop fees covered our event in Johannesburg.

We submitted a funding application to the National Lottery Board but is still awaiting final feedback after our submission last in November last year. Access to this funding will allow us to consolidate our work in two new provinces.

Conclusion

Once again I extend my sincere gratitude and appreciation towards the trustees of PFF who selflessly serve the sector without any expectation of financial gain. We may be small in number but our influence is huge as we invest on many NPOs. A big thanks also to our partners who are very supportive in the execution of our work. We foresee an exciting period ahead as we are stabilising our governance and consolidating our strategic partnerships with various players in the sector.

We are also re-evaluating our events based approach in line with our current capacity. In February 2016 we decided to adopt a more hands on approach and to host forums for NPO leaders to access support for specific organisational issues. It was also felt that we need to meet NPO leaders at their point of need and not just depend on events. As this report is prepared, this approach is already being implemented with great success with a road tour through the Eastern Cape just completed.

We have also launched a mini external evaluation of our programmes by targeting NPO leaders who have attended our events in the past. The results have been very positive so far with very constructive feedback to guide us in the medium term.
